## **WARNING!** CADMIUM IN ORGAN MEATS

**By U.S. Fish & Wildlife Service, N.H. Division of Public Health Services and N.H. Fish and Game Department.**

The results of a study indicate that consumption of moose liver or kidney, or deer liver, may lead to a daily intake of cadmium exceeding recommended levels. Because a normal diet may already exceed advisable levels, the DPHS advises minimizing consumption of these organ meats. If individuals choose to consume deer liver, it is recommended that it be from young animals, in small quantities and infrequently. **Because particularly high cadmium levels have been seen in some moose liver and kidney, the DPHS recommends not consuming these organ meats at all.**

# Moose Hunt Facts

## HUNTING ON PRIVATE LANDS

Hunting is generally permitted on both private and public land, unless otherwise posted. However, there are a few guidelines and restrictions that hunters need to follow to ensure these lands remain open. Remember, your actions can keep lands open to hunting or cause them to be closed.

1. Respect gates and bars placed on roadways to restrict vehicle access.
2. Do not tamper with locked gates.
3. Do not block roads or trails. Park well off the traveled portion of logging roads.
4. Give logging trucks the right of way at all times.
5. Obey "no hunting" signs.
6. Do not hunt within 300 feet of a dwelling or near active logging operations whether you see "no hunting" signs or not.
7. ATV use is prohibited or restricted to designated trails only and is only by prior written permission. A list of designated ATV trails is maintained by the Trails Bureau of the N.H. Dept. of Resources and Economic Development.
8. Unauthorized or overnight camping is not permitted.
9. No fires!
10. Do not litter.

Respecting the landowner's rights will go a long way toward maintaining and improving relations between sportsmen and landowners.
