RSA 214:13-c

Applicants for a Paraplegic License, which may be both combination hunting and fishing license or a fishing only license, must meet the following requirements:

A letter from your physician stating that you are a paraplegic, suffering from permanent loss of or the loss of the use of, both lower extremities.

Along with the letter from your physician, you will also need proof of residency; we require a valid New Hampshire driver's license or non-drivers photo ID.

If you are applying for the combination license, please provide a copy of your previously held hunting license from any state or province of Canada, or a copy of your Hunter Safety Certificate from any State Authorized Hunter Education Program.

The license issued is permanent; it does not need to be renewed.

A \$10.00 one-time administration fee is required.

For a Non Resident Paraplegic License, the applicant must be from a state that we have reciprocity with. The same requirements apply to a non-resident, except their proof of residency which would be their state driver's license. New Hampshire is reciprocal with the following states on this type of license: Vermont, Maine and Massachusetts.

If you qualify for the above license, you may also apply for a Permit to Hunt from a Motor Vehicle.
