



## ANTIQUE ATV & TRAIL BIKE REGISTRATION APPLICATION

## **MACHINE MUST BE AT LEAST 25 YEARS OLD**

NOTE: ONLY 1 INDIVIDUAL PER APPLICATION - REGISTRATIONS ARE ISSUED TO AN INDIVIDUAL.

- Antique ATV and Trail Bike Registrations are only available to Residents of New Hampshire.
- The machine must be at least **25 years old**.
- This is a permanent registration and is only valid for the registered owner, as long as they remain a resident of N.H.
- The plate must be affixed to the machine so that is is clearly visible.
- Antique Registrations cannot be transferred. The owner must register a newly acquired antique at the full price.
   A new registration and plate will be issued. The originally issued plate will no longer be valid and must be removed.

Please note, the requirements for antique snowmobiles are different than antique ATVs and trail bikes.

## Must be at least 18 years of age to register an Off Highway Recreational Vehicle.
